## PROCEEDINGS OF ANNUAL GENERAL BODY MEETING

The Annual General Body Meeting (AGM) of the Indian Society of Agricultural Engineers (ISAE) was convened on the 10 November 2025 at 5:00 P.M. during the 59<sup>th</sup> ISAE Annual Convention at ICAR-CIAE, Bhopal. Initially presence of members was felt lesser and thus meeting was adjourned for about ten minutes for joining the meeting by more members. A significant number of members (137) along with numerous students attended the meeting, which was chaired by Dr. S.N. Jha, President, ISAE. The dais was shared by other office bearers, including the Technical Directors, Council Members, and the Chairpersons of various State Chapters.

The President, Dr. S.N. Jha, welcomed all members to the meeting and expressed gratitude to ICAR-CIAE, Bhopal for hosting the 59<sup>th</sup> Annual Convention. He also extended thanks to Dr. C.R. Mehta, Director CIAE, Bhopal for facilitating and for elaborate arrangements. The President then invited the Secretary General to initiate the proceedings in line with the agenda.

The Secretary General, Dr. P.K. Sahoo, welcomed all the delegates, senior members, industry representatives, and attendees to the General Body Meeting, and thanked everyone for their presence. He presented the agenda items for the meeting requested the approval of the same was endorsed by the members present in AGM.

### Confirmation of Proceedings

The proceedings of the previous Annual General Body Meeting held on 12 November 2024 at Parbhani and the Online General Body Meeting held on 10 August 2025 had been circulated to all members for their feedback by mail and also on the spot in this meeting. Comments had been invited and no feedbacks were received. Both the proceedings were unanimously confirmed by the General body.

### Annual Report for the Year 2024-25

Dr. P.K. Sahoo, Secretary General, presented the detailed Annual Report (**Annexure I**) of the society for the year 2024-25. A printed copy of the report was distributed to all members present. The report was well-received, and the General Body members showed very high level of satisfaction with functioning, achievements of ISAE and comprehensive presentation by Secretary general, and the same Annual Report was formally approved.

### Financial Report by the Treasurer

Dr. A.K. Thakur, Treasurer, presented the financial status of the society for the year 2024-25. He informed the members that the society's total income amounted to Rs. 42,31,706/- . The expenditure for the year was Rs. 28,35,204/- as reflected in the balance sheet for 2024-25. Dr. Thakur also reported that the society's fixed deposits stood at: Rs. 19,263,934/- with Canara Bank and Rs. 5,183,205/- with SBI. The total balance of fixed deposits as of 31 October 2025 was Rs. 26,732,764/- . Treasurer also discussed the financial grants received and those in the

pipeline for the 59<sup>th</sup> ISAE Annual Convention and put up to General body to approve. The balance sheet.

Dr. V. M. Mayande, the past president of ISAE, raised the entries of grant received for TAFE Awards and Jain irrigation awards long back. Even Jain irrigation award has been abolished by the society. These should not carry over forever. He also pointed out entries under schedule 6A Sundry receivable amounts from the 51<sup>st</sup> to 55<sup>th</sup> ISAE annual conventions are very old and not receivable. He proposed to write off these items from the balance sheet. Several senior members, like Dr. Bangali Baboo, Dr. Patil and many other members discussed the issue. **The General body thereafter resolved those above items and any other outdated entries in balance sheet are written off from the next years' and onwards balance sheets of ISAE.**

After above resolve the General Body approved the financial report of 2024-2025 approved as presented.

## Information about ISAE Wall Calendar 2026

Dr. P.K. Sahoo, Secretary General, informed the members about the ISAE Wall Calendar for 2026, which highlights significant technologies developed by Agricultural Engineers and ruling the farms/their respective fields since inception of Agricultural Engineering in India. The cost for printing 1000 copies of the calendar will be borne by the organizing committee of the 59<sup>th</sup> Convention. The calendar was officially released during the inaugural session of the convention.

## Discussion on the Venues for the 60<sup>th</sup> and 61<sup>st</sup> ISAE Annual Conventions

**The 60<sup>th</sup> ISAE Annual Convention:** The Secretary General confirmed that the 60<sup>th</sup> ISAE Annual Convention will be held at Srinagar as approved in last AGM. A team from organizing Srinagar Chapter formally invited the members to grace the upcoming convention.

**The 61<sup>st</sup> ISAE Annual Convention (2027):** The Secretary General presented three proposals received for hosting the 61<sup>st</sup> Convention in 2027 from the chapters at PAU/ICAR-CIPHET Ludhiana, Akola, and Kerala. After a thorough discussion and a voice vote, the General Body approved the proposal to hold the 61<sup>st</sup> ISAE Annual Convention at Thrissur Kerala. However, this approval was subject to the receipt of an official consent letter from the University authorities within 21 days, which have been received well in time, and thus the 61<sup>st</sup> ISAE Annual convention shall be held in KAU, Thrissur, Kerala.

**Revision of Membership Fees and Subscription Rates:** The proposed revision of life membership, annual membership, student membership fees and subscription rates for ISAE journals (JAEI/AET), effective from January 2026, was discussed and approved by the General Body. The proposal was discussed thoroughly and approved by the AGM with voice votes. The approved revised rates w.e.f. from January 1 2026 are as below:

**Receipt and Expenditure Statement for the 58<sup>th</sup> ISAE Convention:** The issue of non-sending the receipt and expenditure audited statement for the 58<sup>th</sup> ISAE Convention held at VNMKV, Parbhani, in November 2024 signed by a chartered accountant to the ISAE Headquarter had not yet been received and was discussed thoroughly. General body took note of the matter and requested the authority/organizer of Parbhanni team to send the same without further delay.

**Allegations by Er. L. K. Lohani on ISAE:** As decided in previous day council meeting the matter concerning allegations of financial bugling made by Er. N.K. Lohani, Director (State Services) in the society and unacceptable languages for its office bearers circulated through various WhatsApp groups not related to ISAE by him several times were decided in previous day council meeting was put in AGM. The General Body took the matter very seriously and approved with consensus that he is defaming ISAE and its office bearers in different WhatsApp groups repetitively. He has not attended even three consecutive meetings (this AGM, council meeting yesterday and online GB meeting held in July 2025) as council member. The General body approved to send a “so-cause-notice” by the Secretary General giving 21 days’ time to explain why not action to be taken against him for defaming the ISAE and its office bearers. The General Body authorized the ISAE Executive committee to decide action based on his reply and provision in the present ISAE Byelaws and rules. Majority of members were of the views that Er. Lohani should be removed from the Council and his primary membership of the society should be revoked as per ISAE byelaws and rules.

**After normal agenda President ISAE requested members to raise Any Other issues for discussion and decision with the permission of Chair**

Dr. R.T. Patil proposed to change the name of ISAE to the Indian Society of Agricultural and Biological Engineers. The matter was discussed and decided against the proposal with voice votes.

Dr. Bangali Baboo suggested that the CA of the society should give a covering letter addressed to General body about audited report of the society.

They also appreciated online award system introduced and improved level of responses of by ISAE office and its executive committee members.

The president informed the house that ISAE has again applied for Co-publishing JAEI with Springer as per decision in last AGM. The general body authorized the Executive committee to sign an MoU in the best interest of the society, if agreed by the Springer and go ahead.

Dr. S.N. Jha, President, thanked all the members for their active participation and contributions to the society and active participation in the meeting. The President also expressed gratitude to the host institute, ICAR-CIAE, Bhopal and the organizing committee of the 59<sup>th</sup> ISAE Annual Convention for their hard work in making the event a grand success.

The meeting concluded with a vote of thanks to the Chair.

### ANNUAL REPORT 2025

Annual Convention 2024 to Annual Convention 2025)

#### **Executive Summary**

The year 2024- 2025 was marked by significant progress for ISAE, with initiatives aimed at strengthening its organizational structure, enhancing academic, scientific pursuit and professional visibility, fostering collaborations, and modernizing its communication and publication systems. The Executive Committee (EC) met **every month** to deliberate and decide **with consensus** on crucial matters of day to day work, policy, publications, member engagement, and outreach. The executive committee arranged general election through an empowered election committee successfully and then new executive committee took charge from April 01, 2025 for three years. The Society also conducted the General Body Meeting (GBM) in online mode on the 10th August 2025, wherein various advancements and strategic priorities were reviewed, discussed and endorsed by all attendee members. The ISAE Council Advisory Committee meetings and chapter meeting were also conducted.

A brief major achievements and action taken during the period a summarized below:

**1. Election of Executive committee** and other council members as per ISAE bye-laws and rules for 2025-2028 were conducted successfully appointing an independent and empowered committee as laid down in ISAE Constitution and bye-laws. It was one of the most vibrant and participating election, in which maximum number of members participated.

#### **2. Strengthening of Governance and Organizational Structure**

- ✓ Key vacant positions/members to be nominated in the ISAE Council (2025–2028) were duly filled through nominations as per ISAE bye-laws and rules.
- ✓ An Advisory Committee was constituted for the 2025–2028 tenure, ensuring due representations from academia, government, industry, and international organizations.
- ✓ Co-opted members from academia and industry were inducted to broaden expertise within the ISAE Council.
- ✓ Committees were formed for standard-making, election reforms, and the for focusing on Irrigation and Drainage Engineering work under the society.

#### **3. Publications and Editorial Developments**

The executive committee is happy to share that our four publications (Journal of Agricultural Engineering(India), Agricultural Engineering Today, Adhunik Krishi Abhiyantrik, and E-newsletter) were published timely and with more contents. Presently JAEI is publishing 18-20 papers in each issue increased from 8-10 papers per issue earlier. The citations of JAEI papers on Google scholar have increased many fold and is 522 (as on 5<sup>th</sup> November 2025). Outreach

of other publications have been increased substantially. Contributors in AET are majorly from Industries. A few major progress on publication front is enumerated below:

- ✓ **Journal of Agricultural Engineering (India) is now MEMBER of Committee on Publication Ethics (COPE).** Journal follows COPE's Principles of Transparency and Best Practice in Scholarly Publishing guidelines for ethical and transparent scholarly publishing.
- ✓ **Journal is selected for abstracting and indexing in Clarivate's ProQuest- a comprehensive database- most-used in libraries across the globe.**
- ✓ **Journal is selected for abstracting and indexing in Cabell's- Journalalytics.**
- ✓ **The *JAEI* has now been accepted for indexing in Web of Science/Clarivate – Emerging Science Citation Index (ESCI).** Journal content is now available in WoS-ESCI database. **Journal is scheduled to receive an Impact Factor in June 2026 when Journal Citation Report (JCR) is released.**
- ✓ **Journal is also indexed in WoS- Biological Abstracts, and BIOSIS Previews.**
- ✓ **ISAE (and its publication JAEI) is included on Research Organization Registry (ROR)**
- ✓ **Journal Editorial System Editorial Dashboard has been upgraded for ease in access and monitoring of review process. Submitting Authors can login using their ORCID.**
- ✓ **During 2024, a total 257 manuscripts received, total 75 articles published in SIX issues (including 2 special Issues). Out of 75 articles, 14 articles (18.7%) contributed by International Authors.**
- ✓ **During 2024, 26 Researchers from EIGHT different countries participated in the review process.**
- ✓ **During 2025, total 200 manuscripts received (till 05th Nov 2022) including 8 manuscripts from other countries (China-2, Ethiopia-1, Thailand-1, Brazil-1, Zimbabwe-1, Iraq-1, Egypt-1).** JAEI now publishes 20 articles per issue.
- ✓ **JAEI editorial board has been expanded with 10 Associate Editors in each Division; with 8 AE from other Countries (USA, Australia, Germany, Türkiye, Iran).**
- ✓ **To address the gender equality, JAEI has included women researchers in each Division (Total= 5) as Associate Editor.**
- ✓ **The editorial board of JAE(I) has been expanded, adding Associate Editors for specialty areas from India as well as abroad.**
- ✓ **The AET editorial board was revised, and appreciation letters were issued to the outgoing members. Page design rates were updated for the first time in several years, beginning July–September 2025.**
- ✓ **A new common email ID was introduced for smoother editorial communication.**
- ✓ **A new policy on paper sharing and authorship misconduct was approved in alignment with COPE (Committee on Publication Ethics) guidelines.**
- ✓ **It has been decided that subscription rates for JAE(I) and AET will be revised from January 2026 considering quality improvements and increased publishing costs.**

- ✓ Journal is under evaluation for indexing and abstracting in Food Science and Technology Abstract (FTSA- comprehensive literature searching in food science and related fields) database of IFIS (International Food Information Services).
- ✓ Journal is under evaluation for indexing and abstracting in Engineering Village database- Geobase and COMPENDEX
- ✓ We have also reached to Springer again for co-publishing of JAEI and is under evaluation by the company. If accepted, we may move to publish JAEI by Springer on mutually agreed terms and conditions.
- ✓ The e-Newsletter editorial board has also been revamped to enhance content planning and outreach.

### 4. Collaborations and MoUs

- ✓ ISAE has signed MoU with ProQuest for abstracting, indexing and sharing revenues, if any
- ✓ The EC has approved a Memorandum of Understanding (MoU) with the Agricultural and Processed Food Products Export Development Authority (APEDA) for mutual cooperation on data sharing and consultancy projects.
- ✓ Preliminary discussions with World Scientific Publishing Co. Pte Ltd were held but later discontinued. ISAE resolved to explore new publishing partners.

### 5. Events and Conferences

- ✓ EC regularly monitored and participated in preparations for the 59<sup>th</sup> ISAE Annual Convention and International Symposium at CIAE. The Convention theme was finalized as “Mechatronics and Robotics in Pre- and Post-Production Agriculture”, with the International Symposium on “Engineering Innovations for Agriculture 5.0.”
- ✓ Preparations for the ISAE's participation in the upcoming CIGR Conference were monitored in multiple EC meetings.
- ✓ ISAE was represented by Dr. Sandeep Mann at the ASABE Annual International Meeting in Toronto, Canada, with appreciation noted for his efforts.
- ✓ President ISAE represented in AAAE conferences held in 2025 and elaborated our activities and requested to have better collaborations with overseas sister organizations.
- ✓ Collaborative activities with Krishi Jagran continued, emphasizing non-financial partnerships for better outreach. ISAE Mumbai Chapter has also participated in form of making stall in one of the Krishi Mela organized by an NGO in Maharashtra.
- ✓ Several Chapters organized numerous activities, conferences/workshops and celebration of designated days related to activities of the society and the same are being brought in form of e-newsletter of the society.

- ✓ During the Annual Convention the President, ISAE and Secretary General, ISAE interact with the 11<sup>th</sup> and 12<sup>th</sup> class students of nearby schools to create enthusiasm and encourage them to choose Agricultural Engineering as profession after school studies. This interaction meeting with school students is happening since 2022 Coimbatore Convention.
- ✓ The farmer's session is organized in each convention since 2022 to access the role of ISAE in addressing the grass-root problems of the farmers.

## 6. Awards and Recognition

- ✓ Online Award application/nominations system was made and launched. All applications/nominations were received online only.
- ✓ Independent Awards Committee was formed in August 2025 for evaluation of applications/nominations
- ✓ The awards scrutiny took place on 15<sup>th</sup> September 2025, followed by EC approval on 21<sup>st</sup> September 2025. Selected awardees were notified, with specific citations approved for the eligible recipients.
- ✓ The Online PhD Thesis Competition 2025 was organized on 27<sup>th</sup> September 2025, successfully recognizing outstanding scholars with entitlements for free registration in the Annual Convention and travel reimbursement.
- ✓ To ensure proactive and larger participation of Industries ISAE introduced appreciation and recognition of select industries from Bhopal Convention.
- ✓ ISAE is being regarded as one of the best and the largest scientific society of India and is being supported by ICAR in form grants for publications and conferences.

## 7. Membership Development and Financial Growth

- ✓ A sustained membership drive was emphasized to expand the Society's network (As on November 01, 2025 we have 6868 members, Life member 4817, Annual member 20, student member 1817, Institutional members 42, Corporate members 112).
- ✓ A massive drive for update of details of members was conducted, but still about 1200 – 1500 members have not yet updated their details and they may not be getting information, journals, magazines etc. from the society.
- ✓ Life membership, annual membership, and admission charges have been recommended for revision from January 2026 to ₹10,000, ₹2,000, and ₹ 500, respectively (subject to AGM approval).
- ✓ Enhanced focus was laid on settlement of pending funds from Parbhani and Patna Chapters and on improving chapter-level reporting and elections.
- ✓ The ISAE got approval of its eligibility to get the CSR funds for its different designated activities to diversify financial support and outreach.

- ✓ Pay for contractual staff at ISAE Headquarters was revised in July 2025, demonstrating the Society's commitment to fair compensation.
- ✓ Revised journal subscription rates were approved to align with global publication standards.
- ✓ Financial position, over all, of the society is good and will be provided the approved balance sheet during the AGM on 10<sup>th</sup> November 2025 for information and ratification/adoption by the members. It is good because of the rent of ISAE flat in Ranjit Nagar, New Delhi, we are getting regularly.
- ✓ To enhance the activities and outreach programme and sustainable system of publication (as we have reached to International standard), a substantial amount annually is required to make ISAE Journal management system robust and sustainable.

## 8. Outreach, Standards, and Technical Initiatives

- ✓ A committee was formed to develop standards for newly developed agricultural machines, in line with ASABE benchmarks, including members from CIAE and BIS. The Society emphasized industry endorsement, aiming to recognize quality agricultural products similar to endorsements in medical associations. Committees working on standard-making and election reform were authorized to expand dynamically for enhanced efficiency.
- ✓ A working committee for enhanced emphasis on Irrigation and Drainage Engineering was also formed.
- ✓ Technical lectures/meeting with industries/workshops were conducted by different chapters and ISAE Headquarter as well.

## 9. ISAE Wall Calendar

Besides regular publications of ISAE, the society also publishes wall calendar since 2022 and the same is continuing.

- ✓ Annual themes and sub-themes for the ISAE Calendar 2026 were actively refined through different meetings. The final theme chosen was "**Impact-full Agricultural Engineering Technologies.**"
- ✓ Institutes across India contributed high-resolution photographs and technical information for the calendar and the best were chosen by the EC through different meetings. Accordingly, calendars were printed and released in the 59<sup>th</sup> ISAE Annual Convention inaugural session on the 10<sup>th</sup> November at CIAE Bhopal.

## 10. Advocacy and Policy Outreach

Multiple advocacy efforts were undertaken:

- ✓ Letters to ministries and manufacturers to increase agricultural engineer recruitment.

- ✓ Recommendation for Agricultural Engineers' inclusion at KVK, Panchayat, and industrial levels.
- ✓ Initiation of liaison with policymakers for job creation and curriculum modernization.
- ✓ Discussions advancing syllabus updates to include next-generation technologies.
- ✓ Letter by central HAM and secretary DoAFW, Government of India have been written to all state Governments CM and Chief Secretary, respectively to establish Directorate of Agricultural Engineering and appoint Agricultural Engineers in each block, Panchayat and district level.
- ✓ The president has personally met with Honorable Dy CM/AM of Bihar and UP, AM of Arunachal Pradesh and various officials of other states to pursue the case.
- ✓ Maharashtra Govt. has created the post of Director Agricultural Engineering and is working to expand the directorate. Similar some progress is in about 11 other states and in few cases it is in advance stage.

The year 2025 has been transformative for ISAE by strategic strengthening of governance, member engagement, policy push, publication quality and outreach programme. With expanded national and international outreach, ISAE continues to progress toward its mission of advancing Agricultural Engineering for sustainable and innovative agricultural development at accelerated rate.
